1. General information

FMY 2022 is an event aimed at exhibiting products from exclusive manufacturers and distributors in the furnishing sector.

Sectors- products to be exhibited in the contest

The event will be held from 24th to 27th May 2022. The opening hours for trade visitors will be uninterrupted from 10.00 am to 7.00 pm. During these hours the stands will have to remain open to visitors and be properly manned.

2. Registration and admission conditions.

Admission conditions

All manufacturers and exclusive distributors of habitat and related services can apply to participate in FMY YECLA 2022.

Space rental Price/rate

Pre-assembled module of 64 square metres comprising: 16 m frontage x 4 m depth (including control electrical panels) = 2,880 € + 10 % VAT. Including electricity consumption of 6 Kw.

Pre-assembled module of 48 square metres comprising: 12 m frontage x 4 m depth (including control electrical panels) = 2,160 € + 10 % VAT. Including electricity consumption of 4 Kw.

- Free space: Free space will be priced at €25 per square metre, and the installation of a platform with a plinth between 8 and 10 cm in height is compulsory.



Exhibitors who are allocated a pre-assembled stand and wish to modify it shall bear all the costs of such modification and shall continue to pay €45 per square metre.

A compulsory damage insurance will be taken out: 30 € + VAT (does not cover civil liability).

Exhibitors who pay the FULL stand price before 15th March 2022 will receive a reduction in the price per square metre of -5 €/square metre, leaving the price for pre-assembled modules at 40 €/square metre, and the price for free floor space at 20 €/square metre. For this purpose, proof of payment must be sent before this date.

Application form, deadlines and method of payment:

The space reservation request must be made by filling in the registration form that appears on the website of La Feria del Mueble de Yecla and, after printing, signing and stamping it, which must be sent to the e-mail address indicated for this purpose.

In order to proceed with the allocation and reservation of the space requested, 50% of the total amount, plus the compulsory insurance (€30) plus VAT (10%), must be paid by 1st March 2022 at the latest.

The remaining 50% must be paid by 20th April 2022 at the latest, which is a prerequisite for collecting parking passes (one pass per stand), etc.

The deadline for submitting the application form and for full payment of the amount of the space requested is 20th April 2022.

After having accepted the space, by means of the application form, the exhibitor's resignation will be cause for forfeiture of the advance payments.

Final acceptance: Final acceptance of participation is reserved to the Management of the Fair, which may reject applications that do not comply with the aims of the Fair.

The Fair Management reserves the right to admit in the first place applications from furniture or habitat manufacturers in general. If the application cannot be accepted, the Fair Management will proceed to refund the amounts paid.

Allocation of space: From 25th April 2022, the date set as the deadline, the management of the Fair will notify interested parties of the applications accepted and the space allocated, invoicing the remaining amount that has not been paid by that date.



Payments will have to be made as follows

The exhibitor will have to send the transfer confirmation together with the registration form.

By paying the receipt corresponding to the participation on the Feria del Mueble Yecla 2022, the exhibitor accepts the general conditions.

In any case, the exhibitor may not proceed with the assembly of the stand until the amount has been paid in full and within the established deadlines.

Assembly dates

- From 16th to 21st May (Monday to Saturday): from 8:00 am to 2:00 pm and from 3:30 pm to 7:00 pm.
- 22th May (Sunday): from 8:30 am to 1:30 pm.
- 23rd May (Monday): from 8:30 am to 1:30 pm. After this time the fair grounds will be closed for cleaning work.

Dismantling dates

- 27th May (Friday): from closing time until 20:00h.
- 30th May to 3rd June: from 8:00 a.m. to 2:00 p.m. and from 3:30 p.m. to 7:00 p.m.

The dismantling and removal of surplus merchandise and materials shall be carried out at the expense of each exhibitor. During the dismantling period, all materials or products on display owned by each exhibitor must be removed from each stand, and the exhibitor shall be obliged to leave the occupied surface area in the same state of conservation in which it was handed over.

Once the date set for dismantling has passed, Feria del Mueble Yecla will be able to dispose of this space without the exhibitor being able to claim anything. The Fair accepts no responsibility for any damage that may be caused to the installations, articles and/or products contained therein, given that after the end of the exhibition other events may be held on the same premises.



3. General services

Installation standards and stand decoration

The exhibitor shall be responsible for the installation of the lighting and interior decoration of the stand, which must be adjusted to the pre-assembled modules. The fabrics to be installed, whether on the ceiling or walls, must have M1 fireproof treatment.

The wiring of the stand will comply with the REBT (Low Voltage Electrotechnical Regulations). No wires may be laid on the floor without the appropriate degree of insulation (1000 V), and connections must always be made in watertight boxes. In addition, an installation bulletin must be available.

The maximum height allowed for stands is 4 metres.

It is compulsory that the inside of the stand can be observed by visitors from the outside, through open spaces that make up at least 50% of the surface area of its façades. It is strictly forbidden to occupy aisles with company products.

Under no circumstances will it be permitted to set up empty stands with simple advertisements or reservation signs. Likewise, stands must remain open during the designated hours of public access to the Fair, from 10.00 a.m. to 7.00 p.m. every day of the Fair.

Signs and advertising of any kind may only be placed inside the stands. In the aisles, other areas of the Exhibition Centre and access to the Fair, advertising may only be placed by Feria del Mueble Yecla or by those expressly authorised by the Fair.

The installations must be completely finished by 23rd May 2022 at 13:30 h so that the Fair can carry out its cleaning work. The Management of Feria del Mueble Yecla is empowered to order the dismantling, at the exhibitor's expense, of those installations that deviate from the established rules, or those that may be subsequently dictated by the same, for the safety and harmony of the overall.

The exhibitor shall ensure that its stand remains in a perfect state of cleanliness and presentation throughout the entire celebration of the Fair (24th-27th May 2022).

No installation, articles or products exhibited therein may be removed before the date set for the end of the show (27th May at 19:00 h).

In order to carry out the dismantling, the exhibitor must prove that he has fully settled his financial obligations with FMY.

The latter reserves the right to carry out these actions at the exhibitor's expense, including the sale of the exhibited product, in order to compensate itself for the amount of the unfulfilled economic obligations, without the exhibitor being able to claim, for any reason whatsoever, any damages that this may cause him/her



Feria del Mueble Yecla, in the event of non-compliance with the aforementioned rules, may proceed to stop the work carried out by the exhibitor or by any person contracted or subcontracted by the exhibitor, in order to ensure that the irregular situation detected is rectified immediately.

Prevention of occupational hazards: In application of the provisions of article 24, in relation to article 18.1 of Law 31/1995, of 8th November, on the Prevention of Occupational Hazards, the exhibitor undertakes to keep Feria del Mueble Yecla informed of any possible occupational hazards arising from the assembly of its stand.

The exhibitor undertakes to comply with the "general rules for the prevention of occupational hazards at Feria del Mueble Yecla", which she/he declares to have read, assuming the responsibilities derived from possible non-compliance, both with regard to his/her workers and the workers of the companies subcontracted by him, where applicable, and third parties that may be affected by his activity, and being contractually the only party responsible to Feria del Mueble Yecla in this matter for the aforementioned concepts.

The exhibitor shall be informed by Feria del Mueble Yecla of the risks existing in the exhibition site and of the corresponding Protection and Prevention measures and undertakes to pass on this information, together with the general occupational risk prevention rules of Feria del Mueble Yecla and the rules of action in emergency situations, to his workers and to any person contracted or subcontracted by him or through third parties, and to demand their compliance during their stay in the Yecla exhibition site.

FERIA DEL MUEBLE YECLA is exempt from liability for any risk that exhibitors, their employees and the personnel subcontracted by the former may run inside the Exhibition Centre, as well as any risks that may be caused to visitors inside the stands.

FERIA DEL MUEBLE YECLA declines all responsibility for the construction and solidity of the stand installations, which corresponds exclusively to the exhibitors, as well as for any damage that may be suffered by their own and other people's goods during loading and unloading.

In order for exhibitors' rights to be effective, in the event of theft (not robbery) on the fairgrounds, it is essential to file the corresponding police report. Feria del Mueble Yecla and the insurance company shall not be liable for theft, loss or damage that may be caused both to the stands and to the articles on display.

The guarding of stands and exhibits throughout the duration of the fair and during the set-up and dismantling period shall be the responsibility of each exhibitor.

Under no circumstances may the Exhibitor claim responsibility from the Management or its employees for theft, loss or damage caused to the material and objects on the stands, for whatever reason. However, the Fair will have security guards on duty 24 hours a day.
